### GENERAL INFORMATION

- A. There will be a brief coaches meeting at 4:40. A no show will be treated as a scratch.
- B. Two heat sheets will be provided to each school.
- C. Spectator admission will be \$4.00 per Adult and \$3.00 for Students**
- D. Heat Sheets will be available for \$2.00 each.
- E. There will be no reseeding due to scratches or errors by Meet Administration or Coaches.

- F. Scoring will be 8 places as follows:
  - 1. Individual events: 9-7-6-5-4-3-2-1 - 2. Relays score double the individual events.
- G. NO Electronic Timing system will be used.  
**Each team is asked to provide 6 workers for timers/recorders .**
- H. Please assign someone to be responsible for clean-up during and after the meet.
- I. There is no insurance coverage for personal or property damage. If there is damage the school or schools causing the damage are liable and must pay the cost of repair or replacement.

### ELGIBILITY

All participants must be eligible under the rules of the OHSAA

### ENTRY LIMITATIONS

- A. Entries may be submitted using Hytek “TEAM MANAGER”, please submit your entries via e-mail to [LPost@bright.net](mailto:LPost@bright.net) An import file of the events will be available for download at [www.CavSwimming.itgo.com](http://www.CavSwimming.itgo.com) . Import this file into Team Manager for this meet. **Entry Deadline is 2-2-09**  
If you do not use “TEAM MANAGER” you may download the manual submission form from our web site.  
All swimmers must be listed on the entry form. Place an “R” beside any contestant who will participate in relay(s) only.
- B. Provable high school times from the 2008-2009 season must be used for the events. If the contestant has not established a time for an event, the contestant’s time must be entered as “NT”
- C. Entries will be limited to 4 per individual event for both Boys and Girls teams. Exception to this is the 50 and 100 freestyle events where there is no limit to the number of entries you may have.
- D. A Team may have up to three entries in each relay event, however; only the A & B relays can score.
- E. A participant may participate in a maximum of 4 events, no more than 2 of which may be individual events.
- F. **THERE WILL BE NO DIVING.** There will be a 10 minute break after the boys 50 Free event #8
- G. A concession stand will be provided.
